The public is invited to review and comment on Amendments to 2040 Long Range Transportation Plan (LRTP) and FY 2015 – 2018 Transportation Improvement Program (TIP), which includes federally-funded transportation projects, such as roads, bridges, public transit projects and grants, bicycle and pedestrian improvements, planned and implemented in the ARTS planning area. This announcement shall serve to fulfill the public review/comment and time requirements for the Federal Transit Administration (FTA) Section 5307 & 5339 Program of Projects funded through FTA Urbanized Area Formula Grant Program, and managed by the Augusta Public Transit Department and Lower Savannah Council of Governments. Pursuant to federal requirements, if no public comments are received during the 30-day public review and comment period, then the "Program of Projects" is final.
